#### Christine Scilleri – WP Teacher

Ms. Scilleri read a letter from a teacher stating the hardships her family is going through because of the unsettled contract. She also told the Board that most teachers go way beyond the school day, coming in early, staying late, attending students sports games, etc., which is getting harder to do with most having to earn supplemental incomes. She asked for a fair and equitable contract.

#### Jennifer Potter - WP Teacher

Ms. Potter spoke on behalf of the WPEA, also stating the extra time and effort that they put into their jobs. She stated as a history teacher, she teaches her students to stand up for what's fair and right. That is why she is asking for a fair and equitable contract.

Mr. Merlino spoke on behalf of the Board. He explained the constraints within budgeting, having to stay within the mandated 2% cap. He said the Board tried to negotiate a 1 year contract, until a new governor was elected, in hopes that changes would be made to this, which the WPEA rejected. He also noted that another offer was made that met the WPEA's request, which also was rejected. He said the Board wants to settle this just as much as the WPEA does and hopes that tonight's fact finding will result in a mutual agreement.
