Mr. Desai had several questions about the budget;

How much are we saving by eliminating aides and how many teachers' jobs will be created with this savings?

Where is the extra money we save when hiring the Principal going to go?

Why can't we eliminate contract for tech services if we have in-house employees?

Are the cameras at CO going to be new or additional?

Did we ask the State for monetary aide for asbestos removal?

What's the current and projected enrollment?

What is the legal maximum amount of student's allowed in a classroom?

What are we paying for a security officer?

Dr. Pillari responded to his questions. The money from reduction of aides will be reallocated to hire more teachers. The extra savings when hiring a new Principal will be put back into the general fund. Our current tech employees are not inhouse and the additional services provided from NRESC is why we contract out. The cameras at CO will be replaced with new updated equipment. He was shown the slide from the presentation with the enrollment figures as well as the estimated amount of students per class. The security officers are shared services with the Borough, which we pay only a portion of the \$77,000 that he stated.
