Presentation: Mayor Kazmark presented a proposal to revamp the veteran memorials on Memorial Dr. The proposal consisted of 14 replanted trees with lights, a monument dedicated to the fallen soldiers from Woodland Park and a history of the original dedications. The town will take care of the long term maintenance of the trees. Open Space Trust Fund has allocated \$30,000 to the project and the American Legion will absorb the cost of the monument, with no cost to the school district. The goal is to rededicate the memorial this Memorial Day.

Eric Luker - Mr. Luker spoke on behalf of the American Legion. He said the legion is excited to take on this project, honoring the soldiers who were killed in action. It not only honors them but also gives the veterans a sense of pride in serving our country.

The Board would like some sort of class or assembly for students to learn the history of Memorial School.
