COMMITTEE REPORTS

Education: Mrs. Bargiel stated that the Education Committee met on 2/12. They discussed the possibility of a summer remedial program for Math & LA. Students who have not met proficient levels on testing will be notified to see if they would like to participate. There would be no cost to the student. They also discussed having an additional class in STEM, but this would be at a cost to the student. Teacher salaries and times would be further discussed.

OLD BUSINESS

Mr. Bolen stated the B&G Committee met briefly before the regular meeting and will continue after the meeting. They discussed the summer programs and the options as to where they will be held. The options would be to hold all classes, summer ESY and remedial programs at CO, purchasing portable air conditioners for classrooms or have just the ESY at CO and utilize air conditioned classrooms at BG & Memorial. Mrs. Mitchell said that the Superintendent, not the Board, should be making this decision. She said Dr. Pillari and Mr. Burrows need to figure it out and implement it.

Mrs. Mitchell asked if the Critical Incident Response committee met. She felt they should have met after the Parkland incident. Since the committee was just formed they haven't met yet. Mr. Bolen will set a date for the committee to meet.
