Dr. Giammarella made the following statement:

"Before beginning this evening's presentation, I would like to make a statement to explain the purpose and set the tone of the meeting. Governor Murphy signed Erin's Law, which mandates all school districts to incorporate age-appropriate sexual abuse prevention and awareness education into Student Learning Standards in grades K-12. The bipartisan sponsors of the bill, Senators Bucco(R) of Morris County, Assemblyman Caputo(D) of Essex County and Assemblywoman Huttle(D) of Bergen County all stated that all children should understand how to recognize and report abuse, abuse is not okay and the trauma caused by abuse is deep and long lasting. The law passed both the State Senate and Assembly unanimously. Through the collaboration and hard work of Dr. Pillari, Mrs. Triglia and the Board's Education Committee, I believe that we have met and clustered the standards for Grades 2, 5 & 8. It was a daunting task but we did not go any further than the standards required, while keeping every activity age and grade appropriate. We followed the requirements but if your child has any questions, please assist us by addressing them. Finally, because of the desire to provide your children with the best education possible, I am confident you will find the presentation acceptable. If you feel uncomfortable, you have the ability to opt out. Thank you."
