She explained that we are getting tuition for the out of district students but legally cannot respond to this specific situation. The busing is given to the lowest responsible bidder when put out to bid.

# **SUPERINTENDENT'S REPORT**

**Education:** Mrs. Bargiel stated the committee met on 3/4/19 and used the time to review data from updated assessments and is showing increments of growth over time, seeing an increase in scores. She believes changes in curriculum are helping with this.

**Community Relation**: Dr. Pillari updated everyone about our social media outlets and asked everyone to follow us to see what's going on in our district. She also informed that there is a translate component on the website in several different languages.

Buildings & Grounds: The committee discussed the summer work at CO, which is scheduled to be completed before the start of school and the penalties if not completed on time. Safety training and for custodians and personal protection equipment. Monthly report from Mr. Burrows. Cleanup behind retaining wall at CO. Conditions of floodgates. Windows at BG. Cameras at BG completed just a small punch list to be completed.

They discussed painting the storage container at CO. Talking about getting a company to beautify the property behind BG & Memorial. Updates on the stream pipe behind CO.

Dr. Pillari responded that the Board will look at the date of EID every year and if it falls on a weekday, school will be closed. Mr. Merlino stated that 3 minutes is the recommended time by the state and was done so to give everyone a chance to speak. She also stated the custodians who are hired without black seal have one year to obtain it.
