The WPEA would like some more details about the job description for the Preschool Intervention and Referral Specialist. Is the position going to be a 10 month or 12-month position? Since we will have more than one pre-school building, is this position district-wide? How will the district pay for the Supervisor after the grant money is used up? When does the grant money expire for the Supervisor positions? Has the district decided on the site for the new pre-k program? If so, when will construction begin? Will we be able to start on September 7th as planned with all the work that needs to be done on a new building?

Dr. Pillari stated the position of Preschool Intervention and Referral Specialist would be a 10-month, union, WPEA scale, position. It is not a supervisory position and would be districtwide. At this time decisions are still being made as to the second location for the pre-school and once there are more concrete answers, the information will be

shared. Mr. Murphy stated the Preschool Intervention and Referral Specialist would be covered by the preschool grant and reiterated it was not a supervisory position.
