SUPERINTENDENT'S REPORT

Parent Teacher conferences throughout the school district proved to be a great success. It was wonderful to see all of our families back in the buildings! A special thank you is extended to our Board of Education for providing all of the staff with a monthly gift of thanks.

School 1 Preschool

On 11/17/2022, our Passaic County Board of Health provided information on the flu vaccine to our Preschool families. In addition, individuals from Berkeley College provided information on various educational opportunities. Our family engagement project for the month of November was the creation and decoration of feathers which were posted on the turkey bulletin board at School 1. Family Engagement Preschool Program Craft for December 2022 will be the decoration of snowflakes which will be hung around the building. CO Preschool

The students enrolled in our preschool program housed at CO School participated in a special election on Election Day in which they voted for their favorite color of the rainbow. Students were able to "vote" in a voting booth that was created by the teachers. The winning color was blue! On November 23rd, students wore "everything blue" to celebrate. Early dismissal days were used to continue our professional education in the area of dyslexia. Our staff learned so much about what is Dyslexia, the subtypes of this reading disability, and various risk factors to recognize.

BG School

Memorial School

Students and staff collaborated with their teams in various activities to promote team building and school spirit. Ryan's Story Assembly took place on 11/18/22. It was a very emotional assembly and our staff and students participated in a pre and post reflection. Winter Band/Choral Concert will take place on 12/21/22.

Math Department

Teachers were provided Professional Development on effectively utilizing 80-minute periods in their classrooms. We also worked on creating and implementing centers into a Math Workshop model. Teachers had time to develop lesson plans with their teams and share successful center ideas.

ELA Department

Teachers in grades K-5 recently completed the Fountas and Pinnell Reading Assessments for the fall. Fountas and Pinnell Assessment allows teachers to individually assess every student to determine their instructional and independent reading levels.
