# **SUPERINTENDENT'S REPORT**

Dr. Pillari reported that the opening of school went smoothly. The Italian class at PV, offered to Memorial students is going well and busing has worked out nicely. The before/aftercare program is up and running, with CO already at capacity. She also welcomed Cedar Grove School District to School #1 and said the traffic flow hasn't been a problem. Dr. Pillari discussed a letter she will be sending the Mayor & Council, asking for Open Space Funding to purchase 2 playgrounds at CO. Back to School Night at all three schools will be held this week, and Dr. Pillari will speak at each one, informing parents about the public question that will be on the ballot and explaining what it is. She discussed possible dates for an open house at School #1. Dr. Pillari also discussed a task force being created within the community to bring awareness to mental health issues.
